
Notes:

Amended vide special resolution passed by the members through extra ordinary general meeting on 27th June, 2025 and ROC and BSE approval dated 21st July, 2025 and 31st July, 2025 respectively.
- Results for the quarter ended Dec 31, 2025 have been prepared in accordance with the Indian Accounting Standards (IND AS) and in accordance with the recognition and measurement principles laid down in IND AS 34 Interim Financial Reporting prescribed u/s 133 of the Companies Act, 2013 read with relevant rules issued there under and other accounting principles generally accepted in India.
- The unaudited Financial results for the Quarter ended 31st Dec, 2025 are subject to limited review by the Auditors.
- The Company is principally engaged in metal fabrication and is managed as one entity governed by the same set of risk and returns. The said treatment is in accordance with the IND AS 108.
- Provision for income tax and deferred tax shall be made at the year-end.
- Figures of the previous years are regrouped and rearranged wherever necessary.
